## 5. Librarian's Report

- 5.1. Financial
  - 5.1.1.A full contingent from the board attended the Town of Arnprior Budget presentation. The presentation was limited to the power point slides and did not include discussion on the the supplementary documentation including the comparators. Trustee Bill Skinner joined the CEO for the presentation to McNab/Braeside Council. There were several questions regarding usage. Township Council will review the ask during their deliberations early in 2020. Arnprior Town Council will also begin budget deliberations in January. Dates to be confirmed. Both treasurers have been provided with updated figures following the Joint User Agreement formula.
  - 5.1.2. The November financial report was reviewed. The provincial grant has been received.
- 5.2. Administration DCA Architects plan to do a site visit in early 2020. The CEO has confirmed the Town of Arnprior will capitalize the renovations. Additionally, the expansion cost may be included in an upcoming review of Development Charges By-Law thereby reducing the amount the library would have to fundraise to bring this project to fruition. It should be noted that the two capital reserves (bequests) earmarked for the expansion are between 15 20 years old.

Celtic Spark Yuletide Concert with the Heather Dale Band was a sell-out performance. NYE tickets are selling well. Two volunteers plan to assist with setup on December 30. The Chair will offer two tickets to each of the mayors to showcase event based fundraising. The Mardi Gras Masquerade Gala, in collaboration with the Arnprior & District Food Bank, has confirmed the Mumbo Jumbo Voodoo Combo Band. Various caterers have been approached to provide quotes for a sampling buffet and a sponsorship pamphlet will be created in the hopes of receiving corporate support for the event. February 22, 2020 has been confirmed as the date.
